1. Honorable Delegate Shaandiin Parrish – not present
2. Chapter Manager, Maricelyn Smith-Williams
 - No funding for Christmas Dinner. The school want to combine another dinner.
 - Toys for Tots still in process.
 - Resolutions to be added: hire (4) College Students to help with firewood and create website, (9) full-time college students at \$500 each, and (5) part-time college students at \$350.00 each.
 - No fund for Housing Discretionary, this all went to Scholarship Funds.

 - Council Delegate Parrish passed legislation for funding to clean up trash, put up trash bins.
 - Glass Bottles is out of control. What can we do?
 - Meeting with Land Management next week.
 - Dig Deep will cost share with the chapter to relocate our watering point and it will be open 24 hours, using a card to get water.
 - Warehouse Project is at DOJ, then Navajo Nation President Nygren will sign off.
 - All of CHINS Modular Home has been delivered.
 - Road Construction Meeting, ADOT working on Drawing a Plan for Pedestrian underpass crossing for people to cross 160 highways with light.
3. Chapter Officials
 - A. Isaac Todachine, Pro-temp Chapter President – Loop Road almost done, need to think about Dedication for the Loop Road and Bridge. When? Need to Discuss this further. Four way stop signs are up and speed limit posted.
