

We went to State Capital in Phoenix for 3 days for Legislative Days regarding Highway 160, lights and walking path crossing to the local market. Met with Governor Katie Hobb, Senator Hatahalie, ADOT cost estimate for \$3.5 million, increase to \$5.9 million. Bill in Phoenix, create and request for \$5.9 million, introduce Bill, lobby there, will go back there, once we get it approve, money goes to Window Rock, we have to go through the 154 process. Warehouse coming along, NN President Signed off, find constructor, cost \$1.4 million, some coming in from APRA, Bid for Audit purpose, advertise in NN Times. Student Woker did a great job, check out their Chapter Website, it has a lot of information.
